3. Bidders can access information and download bidding documents electronically from PPMO's website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders shall submit their bids electronically through the same website within the specified timeframe. Bids received after the stated deadline will be rejected.
4. The bids will be opened in the presence of Bidders' representatives who choose to attend at stated date and time at the office of Lalitpur Metropolitan City Office, Pulchowk, Lalitpur. Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in .pdf format which shall be valid for 30 days beyond the validity period of the bid.
5. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
6. All other pertinent matters not explicitly outlined in this notice shall conform to the provisions stipulated within the prevailing Public Procurement Act of 2063 and Public Procurement Regulation of 2064, including amendments.
